# Wild Blueberry Festival – Arts & Crafts Fair

## August 21 – 23, 2020

### Vendor Information and Application

The Wild Blueberry Festival Arts & Crafts Fair is a family-oriented event celebrating original art and crafts since 1984. It is held on the grounds of the Whitefish Township Community Center in Paradise, Michigan. Each outside space is 10' x 10' on either blacktop or grass. A [fairgrounds diagram](#) is available online. You will need to bring your own set-up and display materials. There are no indoor spaces available. Each space is \$90.00 for all three days of the Festival and is non-refundable. There are a limited number of spaces available with water or electricity. The additional utility fee for the three days of the Festival is \$25.00. Quiet generators are allowed with prior permission and you will be assigned a space outside on the wooded edge of the grounds.

When possible, returning artists will get first choice of spaces available if their approved application and payment are post marked by **March 1, 2020**. Emails confirming receipts of completed applications and payments will be sent to those applicants that provide an email address. Letters indicating application acceptance and space assignments will be sent after the **March 1 deadline**. After the returning vendor spaces have been assigned, the remaining *spaces will be assigned* based on smoke free zones, if requested, category of work, special needs or requests, *on a first come, first serve basis, based on post mark dates of applications and payments and JURY COMMITTEE RECOMMENDATION*. Confirmation letters for these vendor approvals will be sent as spaces are assigned as well.

July and August are peak tourist months for the Paradise area. To lock in your sleeping accommodations, we recommend that you call ahead to reserve the room, cabin, or camping space you desire at least 60 days in advance of the show. Overnight camping in the Festival, School or County Barn properties is not allowed. We have some of the finest camp grounds in the state. **All spaces for the Arts & Crafts Fair have been filled early for the last several years. It is highly suggested that you send your completed application, parking permit and payment as soon as possible to reserve your booth(s).**

## 2020 Wild Blueberry Festival Vendor Expectations and Requirements

**Hospitality:** Please remember to be courteous to other artists and visitors while you are here.

**Original Work:** This is a juried event. All work must be original, made and shown by the artist who rents the space. **Agents or authorized dealers representing the artist or crafter are not allowed.** Kits or commercially manufactured goods such as clothing, candles, screen print T-shirts & sweatshirts, off-set prints from paintings or flea-market items or any **resale** items are not permitted. All applicants whether returning vendors or not will be evaluated to assure original products, each item sold in the vendor's space must have added value by the vendor.

**Parking:** Assigned daily parking for artists will be by permit at the County Barn parking lot next to the Community Center grounds. Be sure to complete and return the parking permit application below if you would like a space reserved. You will receive your parking permit upon arrival and check-in to the Festival. Any special requests for vendor space or parking due to health issues should be noted on the parking permit application. We will do our best to accommodate your requests. **Overnight camping in the Festival, School or County Barn properties is not allowed.**

**Prohibited Products:** Anyone displaying or selling prohibited items will be asked to leave and will not be invited back. Vendors are responsible for compliance with copyright laws and any licensing, including sales tax.

**Prohibited Items: Alcohol, drugs, pets, or items with profanity**

**Photo Files:** We keep pictures of previous applications of arts and crafts on file. If you are a new vendor, please send two pictures representing your items for sale and one photo of the creation process. If you have sent pictures in the past, you only need to **send pictures of new items that you will be selling this year.**

**Setup:** Artists are required to set up all three days of the Festival for the entire time the Arts & Crafts Fair is open. Any early breakdowns or no-shows will not be invited back to future shows. Volunteers are in limited supply. If you feel you may need assistance in setting up, we recommend that you make arrangements for a helper. The Art Fair is open on Friday and Saturday from 9:00 am to 5:00 pm and on Sunday from 9:00 am to 4:00 pm. No early breakdowns are allowed prior to Sunday at 4:00 PM. As a word of caution! Secure your tent well, 50+ lb weights on each corner, and a set up that can withstand 40+ miles per hour gusts of winds. Participating in this event is not for the faint of heart.

**Smoking** For many vendors, smoking near their booths by other vendors and festival volunteers on a regular basis near their space is a health concern. A checkbox has been added to the vendor application. Vendors marking that box will be located in a smoke free area, to the best of our ability.

**Vehicles:** Cars and trucks are not permitted on the fairgrounds (vending area) while the fair is open, 30 minutes before opening, and 30 minutes after closing. This includes entertainment and food vendors. If parking arrangements have not been made, please contact us as soon as possible. Emergency vehicles in a service capacity are exempt from this policy. There are a lot of vendors and festival attendees moving around during this time period and their safety is our prime objective. Vendors may bring hand carts, or small wagons during the restricted times. The hours for vehicle restrictions are listed in the schedule below. Any vendor failing to follow this request will not be invited to return to the fair.

**Severe Weather** For the safety of everyone, when thunder is followed by lightening within a 30 second period, festival participants will be asked by Festival Chairpersons to seek shelter. Outside festival events will be suspended until 30 minutes after the last such bang/clap incident. Vendors are to remain available to continue business after the festival reconvenes or until the festival hours are closed.
